ATTACHMENT #3

In the event of dissolution of the corporation, its assets not required for the payment of its liabilities and obligations, and not held upon condition requiring specific transfer or conveyance upon dissolution, shall be transferred or conveyed to one of more domestic or foreign corporations, societies or organizations engaged in activities substantially similar to one or more of those of this corporation and which at the time of transfer or conveyance would qualify for exemption from taxation under the provisions of section 501 (a) of the Internal Revenue Code of 1954 as an organization described in section 501 (c) (3) of the Internal Revenue Code of 1954, as those sections now exist or may hereafter be amended, or under corresponding provisions of any subsequent federal income tax laws.
